REBATES OR CREDITS FOR HEALTH REASONS

Prior to November of 2002, the Board had no written policy regarding rebates or credits when members are unable to play golf for health reasons or in the event of the death of a member. The policy, which was adopted November 14, 2002, is strictly adhered to so as to provide consistency and fairness to all. The policy is as follows:

Rebates, credits, or membership credits will be made for disability or death as follows:

1. Requests must be in writing and submitted on or before the start of the golf season or June 30th, as appropriate.
2. Sickness or Disability (Substantiated in writing by medical authority)
 - Before start of the golf season-full credit toward next year's membership
 - Before July 1st-1/2 credit toward next year's membership
 - July 1st and thereafter-no credit
3. Death of a member
 - Full rebate before the start of the golf season
 - 1/2 rebate before July 1st
 - No rebate starting July 1st

Restrictions

Youth Membership

- Play Mon-Thurs and Sun after 2:00 pm May 26th--Sept 5th
- Play without restrictions from Opening--May 26th & Sept 6th—Closing

Associate and Youth Memberships qualify to those who's 25th and 17th Birthdays are before April 1st of the 2010 Golf Season.
